CAMPUS SECURITY AND CRIME AWARENESS AT GUPTON-JONES COLLEGE OF FUNERAL SERVICE

In order to comply with Title II of Public Law 101-542, The Crime Awareness and Campus Security Act of 1990; Gupton-Jones College of Funeral Service is required to notify the student of the following information.

- 1. Any observance of criminal activities or other emergencies are to be reported to the Dean or the President of the college who in turn will notify the proper authorities. Prompt and accurate reporting is encouraged. Any failure to report sch activities may lead to more problems. False reporting will be dealt with according to existing laws regarding such.
- 2. The parking lot and campus facilities are not patrolled by employees of Gupton-Jones College or any local law enforcement officer. Lights around the perimeter of the building and also in the parking lot come on at 6:00 pm and turn off at 7:00 am daily.
- 3. The exit doors on the north and south ends of the building remain locked at all times. The entry/exit doors at the front, rear and lab are secured and access may only occur by the use of student's access fob/card. These may be used school days between 6:45 am and 3:45 pm.
- 4. The entire building is secured closed from 4:00 pm Friday until 7:00 am Monday morning during the school year.

To comply with Title II of the Act, beginning July 1, 1991, Gupton-Jones College began to collect data regarding criminal activities which may occur on campus. These activities include but are not necessarily limited to Murder, Rape, Robbery, Aggravated Assault, Burglary and Motor Vehicle theft or vandalism, as well as Sexual Assault (forced/non-forced).

To comply with Title I of the Act, Gupton-Jones College informs any one on campus that the College does not have any "off campus facilities" where business relating to the college is conducted. Gupton-Jones College does not have any "off campus" or "campus" housing facilities. However, students are made aware during the enrollment period that they should secure their motor vehicles and/or personal property any time they are not in their vehicle or in their personal living facility. Students and employees are encouraged to report any criminal activity to the proper law enforcement authority while in their living facilities and traveling to and from the campus in their motor vehicle.

To comply with Title II of the Act, beginning July 1, 1991, Gupton-Jones College began collecting data concerning arrests on campus involving the following activities: liquor law violations, drug abuse violations, and weapons possessions.

To comply with Title II of the Act, A statement pursuant to compliance with Section 1213 of the Higher Education Act of 1965, as amended, addressing the possession, use and sale of alcoholic beverages and the enforcement of underage drinking as well as a policy statement pursuant to Section 22 of Drug Free Schools and Communities Amendments of 1989 Public Law 101-226 relative to the possession, use, and sale of illegal drugs and the enforcement of Federal and State drug laws and description of the drug prevention and education programs as prescribed in Public law 101-226 is made available to students and employees in written form and is included as part of enrollment activities bi-annually.

This policy statement reflects the requirements made of the Gupton-Jones College pursuant to Public Law 101-542 and is written to comply with the regulations to the best of our ability.
